## **Personal Information Daniels Solutions Collects**

## **Personal Information Daniels Solutions Collects Automatically**

Whenever you interact with the Website, we automatically receive and record information on our server logs from your browser including your IP address, "cookie" information, and the page you requested. "Cookies" are identifiers we transfer to your device through our applications that allow us to recognize your device and tell us how and when pages in our site are visited and by how many people. We may also record the referring page or service that linked you to us; other information about the type of Web browser, computer, platform, related Website, and settings you are using; any search terms you have entered on the Website; and other usage activity and data logged by our servers. You may be able to change the preferences on your device to prevent or limit your device's acceptance of cookies, but this may prevent you from taking advantage of the Website's best features. When we collect usage information (such as the numbers and frequency of visitors to the Website), we may use this data in aggregate form, and possibly in a manner that would identify you personally. We may also provide this aggregate information to our partners, so that they can understand how often people use their services and our Website, so that they, too, can provide you with an optimal online experience. We may opt to disclose aggregate information to a partner in a manner that could identify you personally.
